INTRODUCTION

For the implementation of the training content a plan was previously prepared in order to identify what, when, how and to whom it would be implemented. This plan was made by KSK and it was approved for the rest of the partners.

It was considered, among other things, the following ones for 3 different groups in three countries taking into account the following criteria:

- Facilities where the pilot will be done.
- Target groups to make the groups.
- Number of people to allocate in each group.
- Dates of starting and finishing the pilot.
- Schedule of the pilot.
- Teachers for each module or group.
- Procedure to solve any issue during the pilot: overcoming technological barriers.













1. PILOT COURSE IN CROATIA

It will be carried out by KSK with the collaboration of CTM and entities/associations that support people with disabilities. The criteria to be taken into account during this course will be the following:

- Facilities where the pilot will be done: It will be carried out in Split, specifically in a classroom that meets the specified conditions for the proper conduct of the training.
- Target groups to make the groups: Potential students with disabilities.
- Number of people to allocate in each group: a minimum of 15.
- Dates of starting and finishing the pilot: November 2023.
- Schedule of the pilot: Basic concepts of job positions and VR training.
- Teachers for each module or group: 2
- Procedure to solve any issue during the pilot: overcoming technological barriers. Accessibility criteria will be taken into account for a correct implementation of the pilot course.

2. PILOT COURSE IN SPAIN

It will be carried out by FAMDIF with the collaboration of CTM and other entities/associations that support people with disabilities. The criteria to be taken into account during this course will be the following:

- Facilities where the pilot will be done: It will be carried out in Murcia, specifically in a classroom that meets the specified conditions for the proper conduct of the training.
- Target groups to make the groups: Potential students with disabilities in one group and another one over 45 years old.
- Number of people to allocate in each group: a minimum of 15 (in total, a minimum of 30). A total of 2 groups.
- Dates of starting and finishing the pilot: December 2023.
- Schedule of the pilot: Basic concepts of job positions and VR training.













- Teachers for each module or group: 3.
- Procedure to solve any issue during the pilot: overcoming technological barriers. Accessibility criteria will be taken into account for a correct implementation of the pilot course.

3. PILOT COURSE IN GERMANY

It will be carried out by DNV with the collaboration of CTM and entities/associations that support people with disabilities. The criteria to be taken into account during this course will be the following:

- Facilities where the pilot will be done: It will be carried out in Würzburg, specifically in a classroom that meets the specified conditions for the proper conduct of the training.
- Target groups to make the groups: Potential students with disabilities and VET students
- Number of people to allocate in each group: a minimum of 15.
- Dates of starting and finishing the pilot: January 2024.
- Schedule of the pilot: Basic concepts of job positions and VR training.
- Teachers for each module or group: 2
