Introduction

The report presented here details the events of the Second International Seminar that took place in Murcia city (Region of Murcia, Spain), under the organization of CTM with the collaboration of FAMDIF.

The focus of the seminar was the labour inclusion of people with disabilities and was attended by students and professionals from the sector, including freelancers and employees, interested in the latest trends in the stone industry regarding to social inclusion. During this event, the progress made so far in the project was shared.

This work is part of Result 2 "Complete guide to the training itinerary for the teaching of trades in the stone sector to people with different abilities" of the InclusiveStone project, but also was shown results 1 and 3 of the InclusiveStone: "R1 - Educational approach for people with different skills focused on transversal capacities in stone sector" and "R3 - VR-Adaptative Training Content and Evaluation".

Throughout the seminar, tactics to foster inclusion and diversity in the work environment in general were discussed in depth, and then specified in the stone industry. The strengths and areas for improvement of current practices were analysed, considering how they are aligned with the current demands of the sector and with the equality and non-discrimination policies promoted by the European Union.

The dynamic discussions that took place were an excellent opportunity for attendees to deepen their understanding of the value of implementing inclusive policies in the workplace.

This white paper collects the key ideas and suggestions raised during the seminar, with the aim of incorporating significant improvements in the next stages of the InclusiveStone project. In this way, we seek to foster a stone industry that is truly inclusive and reflects the diversity of our society.
